

The Colorado (CASSP) and the National (NASSP) Association of Secondary School Principals are seeking nominations for the 2011 Assistant Principal of the Year Award.

Please nominate assistant principals whom you feel have demonstrated outstanding leadership and are considered to be strong leaders by their colleagues. Candidates must meet each award program's eligibility criteria: Candidate must be a current member of CASE/CASSP and NASSP; must have been an assistant principal at one or more middle level or high schools for a minimum of two years; and must be an assistant principal at the time of selection as the State Assistant Principal of the Year and throughout the year of his or her term (and for national finalists, these conditions must also be met at the time of the National Assistant Principal of the Year interviews in February 2011 and throughout the year of his or her term). **Please submit your nominations to CASE by Friday, September 17, 2010.**

Upon receipt of nominations, CASE will verify the eligibility of each candidate, notify them of their nomination, and provide them with information regarding the application process. **Completed candidate applications are due in the CASE office by October 15, 2010.** Interviews will be conducted and a selection will be made by the CASSP Board of Directors in early November. **Eligibility: Each nominee/candidate: (1) Must be a current member of CASE/CASSP and NASSP; (2) Must have been an assistant principal at one or more middle level or high schools for a minimum of two years; (3) Must complete the NASSP/Virco National Assistant Principal of the Year Award Application; and (4) Must be an assistant principal at the time of selection as State Assistant Principal of the Year (November 2010). For national finalists, these conditions must also be met at the time of the National Assistant Principal of the Year interviews in February 2011 and throughout the year of his or her term.**
